Small Claims Advice Scheme

The Small Claims Advice Scheme is available to assist a business that needs legal advice before taking a dispute further. If the dispute is for a sum **less than £10,000** then, for a **fixed fee of £250 plus VAT**, our trainee solicitors, under supervision, can:

- a. Meet with your business at our offices (or by telephone if easier) for a fixed one hour meeting.*
- b. Listen to and discuss your concerns.
- c. Provide a letter of advice to you, within 48 hours of the meeting, on the basis of the information received.

(The small claims advice scheme applies to all types of claims and is not limited to undisputed debts.)

**Please note, no advice will be given at the fixed one hour meeting.*

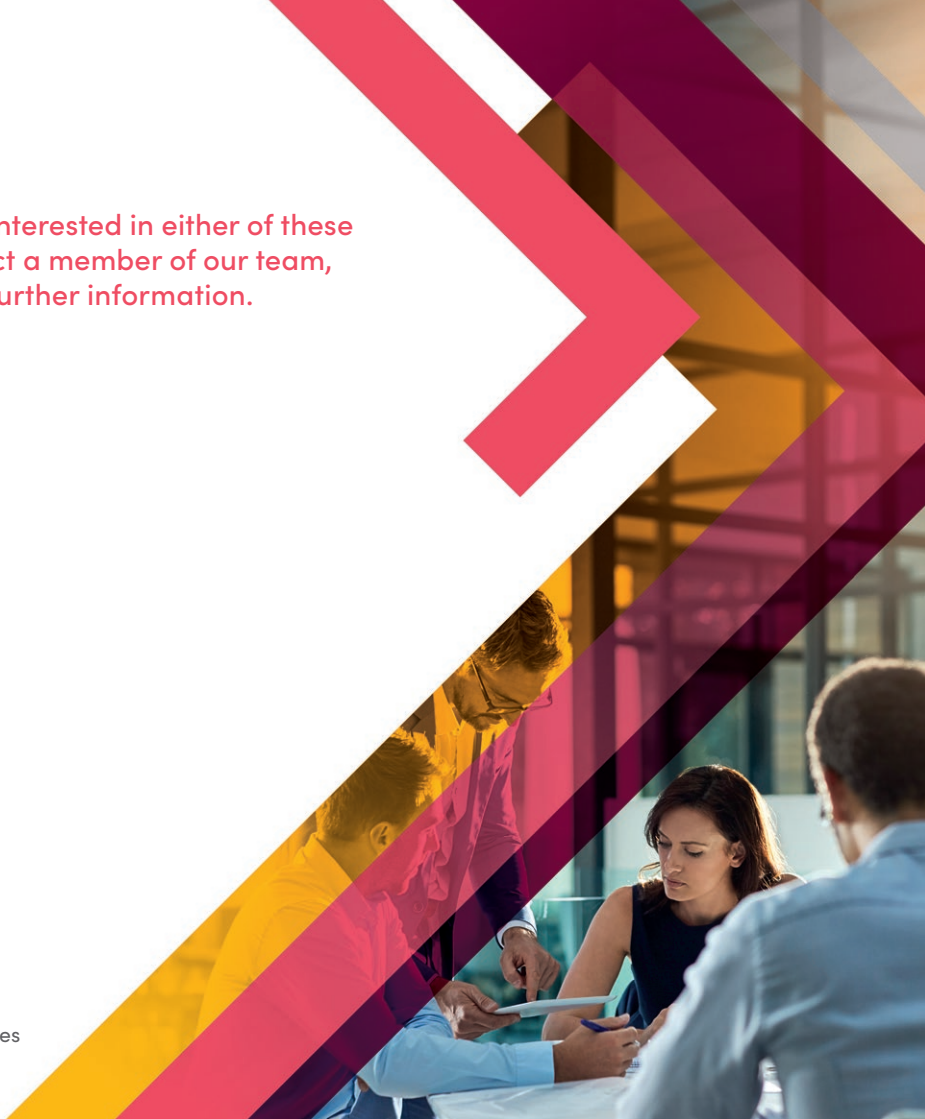
